PAYMENT OF UTILITY BILLS:

- All utility bills are mailed approximately the first day of each month.
- Any utility bill not paid on or before the 15th of the month will be subject to a late charge of \$10.00.
- Any utility bill not paid on or before the 25th of the month by 5:00pm shall subject that utility customer user to an additional late charge of \$40.00 for nonpayment and liable to have the water service disconnected without notice beginning the 26th of the month (unless the 26th falls on a weekend or holiday – disconnection would then take place on the next business day).
- Regardless of whether water has been disconnected, customers shall pay all accumulated late charges.
- Any payment made in the drop box after 5:00pm will be on next day's transaction.

If for some reason you do not get your utility bill, it is still your responsibility to pay your utility bill. Please call or come by Town Hall to find out the amount of your bill!

POLICY #1

NON SUFFICIENT FUND – CHECKS

Effective April 1, 2012, all customers who have two non sufficient fund checks will be on **CASH ONLY BASIS**. No more checks will be allowed as accepted form of payment for the Town of Dundee. This policy will also apply to accounts that are set up as automatic withdraws.

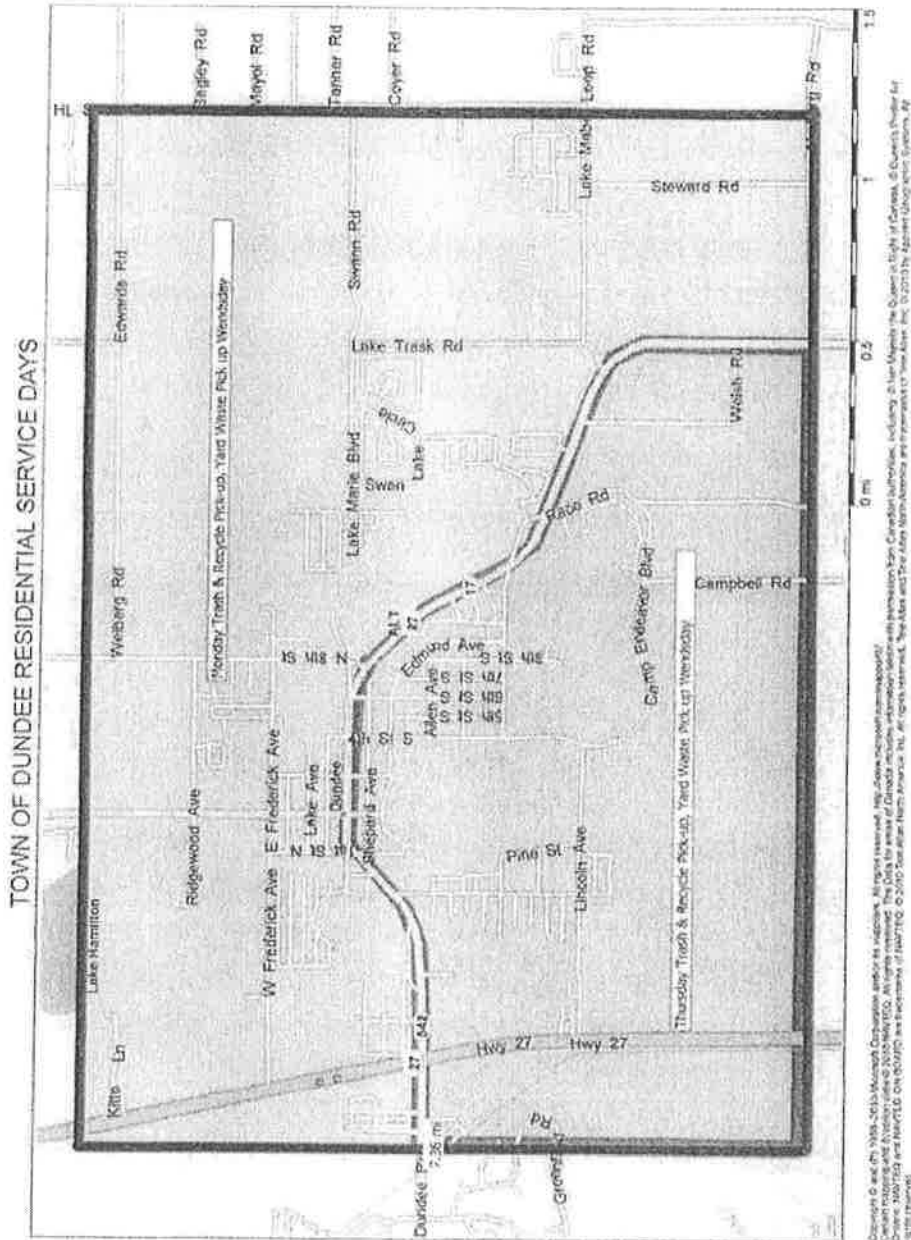

To: Polk County Utilities Water Customers and Citizens in Unincorporated Polk County

The Governing Board of the Southwest Florida Water Management District has returned to the normal year-round watering restrictions for Polk County. Polk County Utilities will allow lawn and landscape watering from groundwater sources **TWO DAYS PER WEEK**, as noted below. Please note that these restrictions apply to everyone with water supplied by Polk County Utilities, private wells, or surface water sources.

Normal year-round irrigation restrictions are as follows:

- On the designated watering days, one may irrigate lawns and landscape **between midnight and 10:00 A.M. or between 4:00 P.M. and midnight.**
- Hand watering or micro-irrigation of landscaping, other than actual lawn areas, is allowed at any time.
- The watering schedule is **two days per week, as follows:**

Address Numbering

- **EVEN ADDRESSES - Homes or Businesses**
- **ODD ADDRESSES - Homes or Businesses**
- **ALL OTHERS - All Common Areas and Properties
Where No Address can be Determined**

Watering Days

Thursday and/or Sunday
Wednesday and/or Saturday
Tuesday and/or Friday

****Reclaimed Water Customers**:** Note that your times and dates are the same as for those using potable water for irrigation. Reclaimed water customers may water between midnight and 10:00 A.M. or between 4:00 P.M. and midnight, as follows: 1) homes or businesses with even addresses may water on Thursday and/or Sunday; 2) homes or businesses with odd addresses may water on Wednesday and/or Saturday; 3) properties where no address can be determined and all common areas may water on Tuesday and/or Friday.

ORDINANCE 04-01

AN ORDINANCE AMENDING SECTION 54-71(c) OF THE CODE OF ORDINANCES OF THE TOWN OF DUNDEE, FLORIDA RELATING TO UTILITIES AND UTILITY SERVICE; REPEALING ALL ORDINANCES IN CONFLICT THEREWITH; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE;

WHEREAS, the Town of Dundee has determined that it is necessary to revise and clarify the manner and procedures in which it renders bills for utility services including late charges and reconnection charges; and

WHEREAS, such revisions and clarifications are beneficial to the residents of the Town of Dundee and will promote the fiscal integrity of the Town's utility services.

THEREFORE BE IT ENACTED BY THE PEOPLE OF THE TOWN OF DUNDEE, FLORIDA:

Section 1. Section 54-71(c) of the Code of Ordinances of the Town of Dundee, Florida, is hereby amended so as to read as follows:“(c) After February 28, 2004, all bills for utility service charges shall be mailed approximately the first of each month. Each bill shall be due and payable on or before the 15th of the month. A utility bill not paid on or before the 15th of the month shall subject that utility customer user to a late charge of \$10.00. Any utility bill not paid on or before the 25th of the month shall subject the user to an additional late charge of \$40.00 for nonpayment and liable to have the water service disconnected without notice beginning on the 26th of the month (unless the 26th falls on a weekend or holiday in which case such disconnection shall be made the following business day). Regardless of whether water has been disconnected, customers shall pay all accumulated late charges. In all cases where water has been disconnected for nonpayment of utility charges, reconnecting the water service to the premises for such user shall be made after payment of all accumulated charges. If such

reconnection is requested to be made after 4:00pm on weekdays, on a weekend, or holidays, an additional charge shall be paid for such "after hours" reconnection of \$60.00. All payments for utility service, late charges, nonpayment fees, and reconnection charges shall be made at the Town Hall during normal business hours."


Section 2. All Ordinances in conflict herewith are hereby repealed.

Section 3. If any provision or portion of this Ordinance is declared by any court of competent jurisdiction to be void, unconstitutional, or unenforceable, then all remaining provisions and portions of this Ordinance shall remain in full force and effect.

Section 4. This Ordinance shall take effect at 12:01am on the day following its second and final reading in the manner provided by law.


PASSED on first reading at a meeting duly assembled and held on the 13th day of January 2004.

READ, PASSED, AND FINALLY ADOPTED on second reading at a meeting of the Town Council duly assembled on the 9th day of March 2004.


